- (2) The Maximum Ex-Depot sale price specified in column (3) of the above table is up to 23 specified locations / depots (excluding Gawadar) of *Pakistan State Oil Company Limited* covering primary freight only, except that for special areas of Baluchistan, Azad Jammu Kashmir and Northern Areas where these include the secondary freight as well. Other than the specified areas, *Pakistan State Oil Company Limited* is allowed to charge secondary freight beyond the 23 locations / depots (excluding Gawadar).
- (3) As per the directives of the Ministry of Energy (Petroleum Division) vide letter # 3(457) / 07 pt dated July 12, 2007, the end consumer prices for retail and direct sales shall be fixed at par and to equate the prices, the dealers commission in case of direct sale price has been merged in PDL.

(4) This Notification shall come into force with effect from July 16, 2025.
